- Applications are taken at the local office 8 to 5 daily Mon-Fri; requirement to go to office unless physically unable and then applicant may call
- Crisis Intervention Program (state fund same in each county) for heating and cooling (very strict on a/c) this fund comes from federal to state and then to county once a year (disbursements until fund is gone) distributed June - July
- LIEAP or Low Income Energy Assistance Program for heating (applications are taken in November each or applications are mailed yearly to previous applicants that still qualify for assistance from LIEAP--this is a mail out to individuals on the Food Stamp Program, etc.) this fund comes from federal to state and then to county once a year; Checks are distributed first of February yearly
- Emergency Assistance Program for house pmts, rent, water, electricity, etc.***requires children in home; this fund is county money by funding July-June (one time disbursement from county & when fund has been depleted there will be no more disbursements to people in need)
