Winter Rates for PSNC are in effect November - April.

Winter Rates for Piedmont, Frontier, and Toccoa are in effect November - March.

Average Annual and Monthly Bills contain the state excise tax of \$0.047/therm for the first 200 therms per month.

The usage for the bills listed above falls within the 200 therms per month level.

All Company Average Usage (Therms) is based on the most recent rate case for each Company.

"Average" for the bottom rows is the simple average for the column or item, except the average is calculated from the other averaged information, including Facilities Charge, Rates, Therms, and "Average Monthly Bill" Excise Tax.
